3 Matters Arising

Proposal to close Golders Green post Office

The Chairman reported that the post office would not be closing for the time being. According to the local press, the shop owner where the post office was to have been transferred had decided that he did not wish to have a post office on the premises, due to a threatened boycott.

Arising out of this item Eva Jacobs had spoken to a representative at the Market Place Post Office who had said that nothing further would happen before 2008. She asked about the petition which she had signed objecting to the restriction of services offered by post offices.

Pavilion Children's Centre

John Boulter had received a cheque for £1,000 from the Administrator, Marian Lowe repaying the RA's loan. She said that the pre-school group which started in 1983 is now self funding and she hoped that they could rely on the RA's support in the future.

Hogarth Hill/Creswick Walk

Carol Boulter reported that CAAC had been told by LB Barnet representatives that planning permission cannot be refused for this decking as there were no grounds for objection.

Simon Abbott was concerned that the RA will take up the position of !no changes' and that the issue of !community benefit' should be taken into account when looking at planning applications. The Chairman pointed out that the RA was bound by the terms of its Constitution.

Trees & Open Spaces Report

David Littaur said that gardening work had been carried out to Central Square in time for the Proms and that it had looked good during the concerts.

Francois Crompton Roberts reported that no action had yet been taken by LB Barnet.

- 4 <u>Question Time</u> There were no questions.
- Approval of a proposal to submit the view from the middle of the Heath Extension North West with Central Square in the foreground and Mill Hill and Hadley Wood in the distance for consideration for protection by the Mayor of London.

This was approved by Council. Derek Chandler will write to the Mayor of London on this.

To ask the officers and the Executive Committee to explore the possibility of returning the Suburb Streets in the East Finchley Ward to the Suburb Ward, if necessary by moving streets not in the Suburb to another Ward. The Chairman thought that the streets which would be affected by the proposal were Howard Walk, The Leys, Neal Close and parts of Ossulton Way, Deansway and Brim Hill. Georgina Malcolm said that this would be good from the point of view of tree planting. Council agreed that this should be carried forward subject to the residents in the affected roads being consulted.

7 Centenary Celebrations

<u>a To authorise expenditure of £10 for a specimen baseball hat and £30 for a Centenary Rubber stamp</u>

Georgina Malcolm circulated an example of the proposed baseball hat with a Centenary Logo. Council approved this expenditure but John Boulter wondered whether it was necessary for this to come to Council to approve. In future it was hoped that the EC would be able to approve expenditure on such miscellaneous items.

b Approval of letter from the RA in support of the Trust's Lottery Application as recommended by the Centenary Committee (draft circulated on 17 June2006)

John Boulter said that he objected to the expenditure of £1,000 but not to the letter but Georgina Malcolm explained that the Trust has offered to pay £2,000 and LB Barnet £1,000 and there is no necessity for a contribution from the RA but the letter of support was necessary. Colin Gregory said that we must show that the community is acting together and support the Trust's application. The Council approved the letter.
