9. Sponsorship Application – Proms St Jude's

An application had been made to the RA to increase the grant from $\pounds 2,750$ to $\pounds 3,000$. LH said that the membership revenue of the RA was about $\pounds 28,000$ a year and she had included a provision for a grant of $\pounds 2,750$ in the 2016 budget.

DLt said that the increased amount in the application was due to increased costs incurred in putting on the concerts..

Some Council members including the Vice Chairman said that they would like to have a proper debate about the grant. In view of the lateness of the hour DBL suggested that Council vote on a Motion to make a grant of £2,750 and that a discussion is held on whether we should increase this to £3,000 at the March Council Meeting when there will be more time.

Jeremy Hershkorn proposed a Motion, seconded by Anita Harlow

That the RA agree to make a grant of £2,750 to St Jude's Proms for 2016 and a discussion on the proposed increase of £250 will be held at the March Council

Simon Sackman proposed an amendment to the Motion, seconded by Tony Ghilchik

That the grant to St Jude's Proms should be increased to £3,000 for 2016

This was passed by Council with 12 votes in favour and 3 against

A further Motion was proposed that the RA should make a grant of £3,000 to St Jude's Proms for 2016

This was passed by Council with 14 votes in favour and 3 against
